Solicitation Ordinance 2024-01

Salt Shed:

Seymore made a motion to accept the quote from Source well – Log Cabin for new 40 x 100' Salt Shed for Tyrone Township. cost of \$124,895.00. All funds to come from ARPA grant. Dashoff seconded the motion. A vote was taken and was carried unanimously.
