**Boom Mower Rental in September 2020:**

The Township will be renting a Boom Mower from Stephenson Equipment, Inc. that will be delivered September 1, 2020 and picked up October 2, 2020. The Township will be able to use the Boom Mower for up to 40 hours a week for each week that it is here.

**District 1 On-Lot Septic Pumping Citations:**

Settle recommended that the Township wait until the end of July to send the second email to the pumper/haulers informing them that the Township needs all of the information they have available for the on-lot septic systems that have been pumped because citations will now be issued to those residents in District 1 who are not in compliance with having their on-lot septic systems pumped. That will give the pumper/haulers the urgency of why we need this information.

The Township received an email from an intern with PennEnvironment requesting the Board to write a letter to the General Assembly regarding single-use plastics. The Board has indicated that they have no interest in participating in writing a letter to the General Assembly on this topic.

Raub made a motion to engage Hammaker East Ltd. to double seal coat the municipal parking lot and driveway in the amount of \$4,864.00 paid out of the General Fund monies. Settle seconded the motion. A vote was taken and carried unanimously.
