**A RESOLUTION OF TYRONE TOWNSHIP, ADAMS COUNTY, PENNSYLVANIA,
ESTABLISHING THE TOWNSHIP'S REPRESENTATIVE AND FEES FOR THE
PURPOSES OF THE TYRONE TOWNSHIP SOLICITATION AND CANVASSING
ORDINANCE, ORDINANCE NO. 2024-01**

WHEREAS, on September 11, 2024, the Board of Supervisors of Tyrone Township enacted the Tyrone Township Solicitation and Canvassing Ordinance, Ordinance No. 2024-01 (the "Ordinance"); and

WHEREAS, pursuant to the Ordinance, the Board of Supervisors of Tyrone Township shall appoint a Township Representative to administer the issuance/denial and supervision/revocation of Licenses; and

WHEREAS, pursuant to the Ordinance the Board of Supervisors of Tyrone Township shall also establish a fee schedule to be used in connection with the Ordinance, which fees may be amended, supplemented or modified by the Board of Supervisors of Tyrone Township by Resolution from time to time.

NOW, THEREFORE, be it **RESOLVED** that the Board of Supervisors of Tyrone Township hereby **RESOLVES**:

1. Constable Conciliation LLC is appointed as the Township's Representative under the Tyrone Township Solicitation and Canvassing Ordinance to administer the issuance/denial and supervision/revocation of Licenses.
2. A License Fee of \$100.00 is hereby established, which fee shall be paid upon application and which fee shall remain in effect until changed or modified by the Board of Supervisors of Tyrone Township.
3. The provisions of this Resolution shall be severable, and if any of its provisions shall be held unconstitutional, illegal or invalid, such unconstitutionality, illegality, or invalidity shall not affect the validity of any of the remaining provisions of this resolution.

4. All resolutions or parts of resolutions inconsistent herewith are expressly repealed to the extent of any inconsistency.
