Call to Order:Call to Order:Mosley called the meeting to order at 7:00 PM.Pledge of Allegiance:Mosley led the Pledge of Allegiance.

Approval of Board of Supervisors Meeting Minutes:

Dashoff made a motion to approve the minutes for the September 13, 2023 Board of Supervisors Meeting. Mosley seconded the motion. A vote was taken and the motion was carried unanimously.

Approval and Payment of the September 2023 Accounts Payable Invoices and Credit Card Purchases:

<u>Salt Shed:</u> agreed that it needs repaired but requesting additional quotes. <u>Affidavits of Septic-non-compliance:</u> 4 were served. 1 was completed.

New Business:

2024 Tentative Road work for 2024

Tar & Chip: (Rock Valley, E. Chestnut, Conrad, Coon, Gardners Station to woods, Pond & State Game land Rd.) – Erik Vranich and Greg Kepner to assess needs.

Drain Pipes: 5 drain pipes need replaced on E. Chestnut Hill Rd. 1 cement drain pipe needs cleaned up (e. Chestnut Hill Rd). 1 drain pipe at Oak Grove Rd. needs replaced. Funt Rd under serious consideration. Estimated costs approximately \$5000.00 if ordered this year verses higher costs to purchase after 1st of year. Erik to send material list.

Akshay Vidyarthi Preliminary/Final Subdivision Plan for lots 6-12 -Consideration & Action:

Erik Vranich gave update for consideration to conditionally approve lots 6-12 pending satisfactory completion of all remaining comments within the Wm. F. Hill & Assoc. letter dated September 8, 2023 – Mosley made motion to accept conditional approval pending the completions as outlined of the Sept. 8, 2023 letter, Dashoff seconded the Motion. A vote was taken and the motion was carried unanimously. Lasarus – Solace Wellness – Preliminary/Findal Land Development Plan: Erik Vranich stated this property is proposing to further develop this property into a professional office use, including all necessary access and related infrastructure. The planning commission has reviewed this plan and recommended conditional approval pending satisfactory completion of all outstanding comments within the September 13, 2023 letter from Wm F Hill & Assoc. The planning commission also recommended approval of the sever waivers that were requested, one waiver with a condition.

1. Action on Waivers:

- a. Motion to approve a waiver of SALDO 10-504.B.1 to allow access drives within 200 feet of the intersection, noting that PennDOT has already approved the entrance for this location. Mosley made a motion to approve waiver of SALDO 10-504.B.1, Dashoff seconded the motion. A vote was taken and the motion was carried unanimously.
- Motion to approve a waiver of SALDO 10-505.A to waive the requirement for curbing since bumper blocks are proposed and PennDOT, in their recent project did not install curbing at this location. Mosley made a motion to approve waiver of SALDO 10-505.A, Dashoff seconded the motion. A vote was taken and the motion was carried unanimously
- c. Motion to approve a waiver of SALDO 10-506.A to waive the requirement for sidewalk since no pedestrian access measures were installed as part of the intersection improvements project. Mosley made a motion to approve waiver of SALDO 10-506.A, Dashoff seconded the motion. A vote was taken and the motion was carried unanimously

d. Motion to approve a waiver of SALDO 10-511. B.2 and 515.G, which is a waiver of the requirement for landscape buffering between the Lazarus property and the Mike Meyers property with the condition that Lazarus obtain a letter from Mr. Meyers that they do not object to the waiver request and not having landscaping in this area. Otherwise, no waiver would be allowed and landscaping would be required. Mosley made a motion to approve waiver of SALDO 10-511. B.2 & 515.G with the condition Lazarus obtain a letter from Mr. Meyers as stated. Dashoff seconded the motion. A vote was taken and the motion was Carried unanimously.

<u>Andato LLC Minor Final Subdivision and Land Development Plan</u>: Applicant submitted a time extension request due to a revised plan that has been submitted to the Township and is currently under review. Mosley made a motion to accept the extension from October 24, 2023 to January 22, 2024. Dashoff seconded the motion. A vote was taken and the motion was carried unanimously.
