The Board of Supervisors Meeting for Wednesday, September 14, 2022 was held at the Tyrone Township Municipal Building, 5280 Old Harrisburg Road, York Springs, PA 17372, Adams County, Pennsylvania.

<u>Call to Order:</u> Raub called the meeting to order at 6:00 PM. <u>Pledge of Allegiance:</u> Raub led the Pledge of Allegiance.

Approval of Board of Supervisors Meeting Minutes:

Mosley made a motion to approve the minutes for the August 24, 2022 Board of Supervisors meeting. Raub seconded the motion. A vote was taken and the motion carried unanimously.

Community Media:

Public Participation:

- Mr. Richwine inquired who inquired regarding seal coating. Raub indicated that a taxpayer was opposed to the Township's recent seal coating and requested that the Township apply asphalt coatings to the roads instead of the double seal coating. Raub elaborated that he would love to apply asphalt to the roads, but the double seal coating cost the Township ~\$200,000 to complete, while asphalt coating is estimated to cost over \$1.5M to satisfy the taxpayer's request. The Township does not have the funds to apply asphalt coating to the roads.
- Raub inquired if the Board wished to request Dashoff to engage Alpha Space Control so that the Township may learn when line painting will occur on Township roads. The Board agreed, so Raub requested that McFadden contact Dashoff.
- Mr. Richwine commented that it does not look like there are enough parking spaces painted in the Township parking lot.
