

**MINUTES OF MEETING OF

December 11, 2024**

The Board of Supervisors Meeting Wednesday, December 11, 2024, was held at the Tyrone Township Municipal Building, 5280 Old Harrisburg Road, York Springs, PA 17372, Adams County, Pennsylvania

**Call to Order:** Mosley called the meeting to order at 7:00 PM.

**Pledge of Allegiance:** Mosley led the Pledge of Allegiance.

**Approval of Board of Supervisors Meeting Minutes:**

Seymore made a motion to approve the minutes for the November 13, 2024, Board of Supervisors Meeting. Dashoff seconded the motion. A vote was taken, and it was carried unanimously.

**Approval and Payment of the Accounts Payable Invoices, Monthly Bank Run Statements and Credit Card Purchases for November 2024:**

Dashoff made a motion to approve payment of the Accounts Payable Invoices, the payments made in the second check run of November 2024, the Bank monthly transactions, and Credit Card purchases for November 2024. Mosley seconded the motion. A vote was taken, and it was carried unanimously.

**Old Business:**

- 2025 Township budget approved and posted on the Adams County website
- Auditor approved - SEK of Hanover will be the new auditor for 2024, 2025, and 2026
- 2024 Bendersville Fire Co. donation approved
- NPDES Renewal approved for 2025 2026 (2-year renewal)

**New Business:**

- State Police fines received were \$800.47.  
This money is a portion of the fines that are collected in the Tyrone Township district.
- 2024 Heidlersburg Fire Co donation: \$35,000  
The Heidlersburg Fire Company submitted their 2023 Federal 990 Income Tax Report and 2023 invoices detailing the usage of the funds. Tyrone Township does not have a fire tax, and this donation serves as a substitute for it. Dashoff made a motion to approve the donation, and Seymore seconded the motion. A vote was taken, and it carried unanimously.

- New Dump Truck Purchase of \$127,144.47 (paid with surplus 2024 funds)  
Seymore updated attendees on the new dump truck purchase. Research was conducted on several trucks, and they were able to find a vehicle well within the township budget. Seymore then provided a summary description of the vehicle as a 2023 Chevy Silverado (new) dump truck with a stainless-steel bed, plow,

hydraulic tilt, electric salter, automatic transmission, and other features. Drivers will not need a CDL to operate this truck. COSAR approved (state program). The total price including tax and tags \$127,144.47. Seymore suggested that a motion be made to purchase the truck with the caveat that a decision to sell a truck be made by the July 9 meeting. Dashoff made a motion, and Seymore seconded the motion. A vote was taken and it carried unanimously.

Mosley made a motion to process the 2024 donations for the organizations, and Dashoff seconded the motion. A vote was taken, and it carried unanimously.

- Donations to the Bendersville Fire Company and Heidlersburg Fire Company are directed to the general fund and are based on receiving the necessary annual documentation as required by law.
